Willmott Dixon Construction have been awarded the contract from Buckinghamshire Council to provide a new Sports Hall and Classroom block, with Hard and Soft Landscaping areas, associated External Works and Refurbishment works to the existing school.

We are due to commence the main construction works in November, with planned completion of our construction works in November 2021.



***Our current works on site include the following:***

We have delivered our temporary offices via the Watchet Lane entrance and are nearing the completion of erecting our perimeter hoarding. Our enabling works include the construction of a temporary access road, which will be formed through the Senior School playing field.

Following the completion of the access road, we will commence with excavating the existing ground to the old tennis courts in preparation for pouring foundations. Progress photos coming soon.....
